### XTEK Market Update

**Canberra – Thursday 16 June 2016:** XTEK Limited (ASX:XTE), is pleased to provide a market update on a number of activities.

#### Showcasing XTAtlas™

At the invitation of the Australian Capital Territory Government, XTEK will be showcasing XTAtlas™, XTEK's contextual video and mosaic mapping technology, to a Global Supply Chain Forum in Canberra on 16 June 2016. The unique XTAtlas™ technology geo-references live aerial video onto a digital map to deliver high definition video images in context to the map in real-time.

XTEK aims to license the XTAtlas™ technology with multiple Unmanned Aerial Systems (UAS) suppliers to integrate XTAtlas™ into their systems and also build and sell XTEK XTAtlas™ capable UAS. The Global Supply Chain Forum involving executives from several global defence prime contractors, will provide excellent opportunities for the commercialisation of XTAtlas™.

#### Share Purchase Plan

XTEK has a Share Purchase Plan (SPP) closing on 22 June 2016. The SPP provides all eligible shareholders with the opportunity to increase their shareholding in the Company at a 12.5% discount to the volume weighted average price over the 5 trading days prior to and including the Closing Date of the Offer, subject to a maximum price of \$0.42 per share.
